| intended use | The Miuton Medical Mask is designed to use in the medical non-sterile working environment (eg. hospital)to filter the particulate matter in the air and block the droplets, blood, body fluids and secretions. |

[Instruction for use]

1. Place fingers inside the medical mask. Bend the nose clip around fingers to form

2. Hold the medical mask in position over the nose and mouth, and pull the head harness behand the ears.

3. Using both hands, form the nose clip around the nose and shift the head harness to ensure a positive face seal.

4. Fit check a) To test the fit of the medical mask without an exhalation valve, cup both hands over mask and inhale sharply. b) If air flow is felt in the nose area, re-adjust the noses clip. c) If are flows is felt around the edges of the respirator, re-position the medical protective mask to achieve a better fit.

5. Change the mask immediately if breathing becomes difficult or mask becomes damaged or distorted.

6. Change the mask if a proper face seal cannot be achieved.

7. Careful observances of these instructions is an important step in safe respirator use.

[Scope of Application] It's used in the medical working environment to filter the particulate matter in the air and block the droplets, blood, body fluids and secretions.

[Main Performance] Under the condition of gas flow rate (85±2) L/min, the filtration ivel of the mask for non-oily particles is level 1, and the filtration efficiency should not be lower than

95%; In the case of gas flow (85 ± 2) L/min, the inhalation resistance of the mask should not exceed 343.2pa (35mmH2O). Synthetic blood is sprayed towards the mask sample at a pressure of 10.7kPa (80mmHg), and there should be no penetration inside the mask. [Main Structure & Composition]

Medical mask is composed of surface layer filtering layer inner layer, nasal splint, and mask bandage. The surface layer and the inner layer are made of non-stick non-woven fabric. The filtering layer is made of melt-blown non-woven fabric. The nasal splint is made of bendable plastic. The mask bandage is made of elastic material such as non-woven fabric.

[Recommended Life Time] No more than 72 hours [Storage] Stored in a warehouse with room temperature, dry and well ventilated environment.

[Notes, Warnings & Tips]

(1)When the product is marked with sterile product. It is forbidden to use if the packaging is damaged.

(2)Do not touch liquid or flame before using the product.

(3)Please stop using the product immediately if you have any discomfort during using.
